**Laclede County Health Department Announces
47 New Laboratory Confirmed Positive COVID-19 Case(s)
Reported 07/17/2021 - 07/19/2021**

LACLEDE COUNTY, MO – The Laclede County Health Department has received notification of forty-seven (47) additional positive laboratory confirmed case(s) of COVID-19 in Laclede County. Our total is now four-thousand-eighty-two (4082) cases to date; two-hundred-sixty (260) currently being monitored, three-thousand-seven-hundred-forty-six (3746) considered recovered, seventy-six (76) deaths, and multiple close contacts being monitored daily. Our agency will not be releasing personal information, to protect the individuals' identity. Recommended notification and testing of identified close contacts, and quarantine/isolation instructions have been provided. Monitoring of active cases and close contacts will be completed for the quarantine/isolation period, as appropriate.

Vaccination Status of Cases #4037 - #4083

- **Not Vaccinated – 38**
- **Not Vaccinated / Not Eligible (under age 12) – 1**
- **Vaccinated (1st Dose) – 3 - Moderna**
- **Vaccinated (1st & 2nd Dose) – 2 – Pfizer 2 – J & J**
- **Breakthrough Cases (Requiring Hospitalization and/or Death) – 1 – Moderna**
 - **Total Breakthrough Cases Reported To Date – 2 - Moderna**

Symptoms of COVID-19 illness may include: fever, cough, shortness of breath/difficulty breathing, chills, muscle pain, headache, sore throat, new loss of taste or smell. It should be understood that with the continued community illness spread, any public activity should be considered a potential exposure risk, and all precautions need to be taken for your personal protection.
