**Laclede County Health Department Announces  
28 New Laboratory Confirmed Positive COVID-19 Case(s)  
Reported 07/31/2021 – 08/02/2021  
Case #4388 - #4415**

LACLEDE COUNTY, MO – The Laclede County Health Department has received notification of twenty-eight (28) additional positive laboratory confirmed case(s) of COVID-19 in Laclede County. Our total is now four-thousand-four-hundred-fourteen (4414) cases to date; four-hundred-nineteen (419) currently being monitored, three-thousand-nine-hundred-six (3906) considered recovered and eighty-nine (89) deaths. Our agency will not be releasing personal information, to protect the individuals' identity. Quarantine and isolation instructions have been provided to the positive case, with recommendations to notify their close contacts. Monitoring of active cases will be completed for the quarantine/isolation period.

  - **Identified as Close Contact to a Positive Case – 4**

**Vaccination Status of Cases #4388 - #4415**

- **Not Vaccinated – 23**
- **Not Vaccinated / Not Eligible (under age 12) – 0**
- **Vaccinated (1<sup>st</sup> Dose) – 1 - Moderna**
- **Vaccinated (1<sup>st</sup> & 2<sup>nd</sup> Dose) – 2 – Moderna 2 –Pfizer**
- **Breakthrough Cases (Requiring Hospitalization and/or Death) – 0**
  - **Total Breakthrough Cases Reported To Date – 4 – Moderna 1 – Pfizer**
