**Laclede County Health Department Announces  
11 New Laboratory Confirmed Positive COVID-19 Case(s)  
Reported 09/23/2021 – 09/24/2021  
Case #5161 - #5171**

LACLEDE COUNTY, MO – The Laclede County Health Department has received notification of eleven (11) additional positive laboratory confirmed case(s) of COVID-19 in Laclede County. Our total is now five-thousand-one-hundred-seventy (5170) cases to date; ninety-four (94) currently being monitored, four-thousand-nine-hundred-fifty (4950) considered recovered and one-hundred-twenty-six (126) deaths. Our agency will not be releasing personal information, to protect the individuals' identity. Quarantine and isolation instructions have been provided to the positive case, with recommendations to notify their close contacts. Monitoring of active cases will be completed for the quarantine/isolation period.

Included in the cases above: four (4) case identified as an employee or resident in a Long Term Residential Care Facility. All exposed staff, residents, and family/guardian contacts have been notified. The Facility is working with Long Term Case Regulation to monitor and address this situation.
